Child Marriage



ARTICLE 5: A marriage may be allowed for a man whose age is 20 years or more and a woman whose age is 18 years or more. In a special case where a man does not reach the age of 20 years and where a woman does not reach the age of 18 years, a marriage may be legitimized, upon the consent of the parents or guardians,

if the woman becomes pregnant.
