LABOUR LAW SECTIONS 10 &11 DEFINE - CHILD LABOR & YOUTH LABOR

- 10. Youth labor means employees aged between twelve and under eighteen years;
- 11. Child labor means youth labor unauthorized to work in dangerous jobs or sectors, working overtime, or undertaking hard labor, including children under the age of twelve years undertaking economic work;

Children of ages **12 and 13** may be employed for "light work" provided they shall not be required to undertake work that is unsafe, interferes with their schooling or vocational training, or is dangerous to their body, psychology, or mind.

It is compulsory for all children above six years old to go to school and finish Elementary School Education
